The County Sheriff's Civil offices have been impacted by the COVID-19 response, court closures and Governor Newsom's Executive Order N-28-20. Sheriff's offices are accepting documents with certain restrictions but may not be able to abide by previously established timelines.

The LA County Sheriff's Dept will not accept any process, unless it was issued after March 19, 2020 and where a court has determined it to be urgent. All eviction process will be placed "on hold", even that which is already in their possession, unless it is determined to be urgent.
